#### POLICY FOR DETERMINATION OF MATERIALITY OF ANY EVENTS / INFORMATION

(AMENDED IN BOARD MEETING HELD ON 11.08.2023)

#### 1. PREFACE:

The Board of Directors (the "Board") of H S India Limited (the "Company") has adopted the following policy and procedures with regard to determination of materiality of events or information which are required to be disclosed to the Stock Exchanges in terms of Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations) (The Policy). This Policy has been formulated in accordance with Clause (ii) of sub-regulation (4) of Regulation 30 of the Listing Regulations.

#### 2. PURPOSE OF THE POLICY:

The purpose of this Policy is to determine materiality of events and information based on criteria specified under clause (i) of sub-regulation (4) of Regulation 30 of the Listing Regulations and to ensure that the Company shall make disclosure of events / information specified in para A and B of Part A of Schedule III of the Listing Regulations to the Stock Exchanges.

## 3.CRITERIA FOR DETERMINATION OF MATERIALITY OF EVENTS / INFORMATION:

The Company shall consider the criteria as specified in clause (i) of sub-regulation 4 of Regulation 30 of the Listing Regulations for determination of materiality of events / information.

#### 4. DISCLOSURE OF EVENTS OR INFORMATION:

- A. The following events / information specified in Para A of Part A of Schedule III to the Listing Regulations upon occurrence of which the Company shall make disclosure to the Stock Exchanges without any application of the guidelines for materiality:
  - 1. Under the system, Chief Executive Officer, Chief Finance Officer, Vice President, Associate Vice President, Head of the Departments who are responsible for relevant areas of the Company's operations (Responsible Officers) must report to Managing Director or Chief Executive Officer of the Company any events / information which may possibly be material or of which the responsible officer is unsure as to its materiality. - i. Review events / information and to take whatever steps necessary to verify its accuracy;
- ii. Assess whether the events / information is required to be disclosed to the Stock Exchanges under the Listing Regulations;
- iii. Report the matter to Managing Director or Chief Executive Officer of the Company that events / information is material and requires disclosure under Regulation 30 of the Listing Regulations.

Where the Managing Director or Chief Executive Officer or Company Secretary is not certain about materiality of events / information, they may refer matter for external legal advice.

The procedure to be followed in relation to the lodgment of announcement of material events / information is as follows:

- (a) **Prepare draft announcement to the Stock Exchanges:** If the events / information is material, the Company Secretary will prepare draft announcement to the Stock Exchanges which is factual and expressed in clear manner and obtain approval of Managing Director or Chief Executive Officer of the Company.
- (b) **Lodge Announcements:** The Company Secretary on behalf of the Company will lodge or arrange for lodgment of the announcement with the Stock Exchanges.
- (c) **Post announcement on website:** After lodgment of the announcement with the Stock Exchanges, the Company Secretary will arrange to place it on the website of the Company. All the announcements made under this Policy shall be kept on the website as per the Archival Policy of the Company.

#### 6. COMMUNICATION OF THIS POLICY:

Human Resource Department of the Company are required to notify and communicate the existence and contents of the Policy to the existing Employees and Directors of the Company. For all new Employees and Directors shall be informed about the policy by Human Resource Department. This Policy shall also be posted on the website of the Company.

#### 7. AMENDMENT:

Any change in the Policy shall be approved by the Board of Directors of the Company. The Board of Directors shall have the right to withdraw and / or amend any part of this Policy or the entire Policy, at any time, as it deems fit, or from time to time, and the decision of the Board in this respect shall be final and binding. However, no such amendment/modification shall be inconsistent with the applicable provisions of any law for the time being in force.
